

ECVSMR - Initial Applicant Pathway

The registration for the IAP will stop on September 19th 2022

1. Introduction

The Initial Applicant Pathway to ECVSMR certification is open for those persons who have sufficient credentials to sit the examination without having undergone formal residency training.

2. Guidelines for applicants

The following describes the criteria that must be fulfilled by the applicant.

2.1 Qualifications

- Only applicants who are eligible to practice veterinary medicine in Europe will be accepted.
- Applicants must supply documentation of advanced training in topics related to sports medicine and/or rehabilitation (e.g. completion of a post-graduate degree in topics related to sports medicine or rehabilitation, rehabilitation certification by national bodies, track record of attending topic specific continuing education courses).

2.2 Practising in Europe

Applicants must supply documentation to show that they are eligible to practice in Europe.

2.3 Experience and practice

- Applicants must have at least five years' experience practising the speciality as:
 - a) A faculty member in a veterinary school involved in clinical, teaching, and/or research aspects of sports medicine and/or rehabilitation (60% of time),
or
 - b) A practitioner spending at least 60% of her/his time in the field of sports medicine and/or rehabilitation,
or
 - c) a combination of a) and b)

- Applicants must provide self-certification that she/he has, in the past five years, seen 400 cases (canine) or 300 cases (equine) related to the field, as described in the P&Ps of the ECVSMR in the sections “small animal track” or “equine track”.

2.4 Teaching

Applicants must supply documentation that shows that they:

- have been an invited speaker at multiple international or national scientific/veterinary conferences on topics related to sports medicine and/or rehabilitation
- have significant experience teaching courses related to sports medicine and/or rehabilitation in veterinary schools, graduate schools, or professional continuing education programmes.

2.5 Research and publications

Applicants must demonstrate scholarship in the discipline by having been first or last author of at least two significant hypothesis-driven publications in peer-reviewed journals (available from the ISI Web of Knowledge Journal Citation Report) resulting from research or practice in the speciality.

- The author must be able to show that the publication covers at least one of the subject-specific areas of knowledge outlined in the ECVSMR P&Ps.
- At least one of these publications must be an original paper, defined as a manuscript that describes a hypothesis-driven experimental study utilizing *in vivo*, *ex vivo* or *in vitro* techniques to address an objective relevant to the speciality, or a prospective or retrospective clinical study addressing a question relevant to the speciality and including at least 20 cases.
- The second publication can be one of the above or a first author case report or small case series.

The paper must be published

- in a peer-reviewed journal of international standing relevant to the speciality. The applicant is responsible for submitting a copy of the citation index page, available from the editor of the journal, or the ISI Web of Knowledge Journal Citation Report at the time of submission.
- in an English-language journal. In individual cases where a paper has been published in a peer-reviewed journal in a language other than English, the initial applicant may apply to the Credentials Committee to have this recognised. The application must be accompanied by an English translation of the paper.

Applicants must submit electronic copies of their published manuscripts with their application. 'In press' manuscripts can be submitted, provided that the applicant submits a written confirmation from the editor of an approved journal confirming that the paper has been accepted for publication.

2.6 Letters of support

Applicants must supply two letters of recommendation from Diplomates (European and/or American) who are personally aware of the applicant's activities and professional contributions in the area of sports medicine and/or rehabilitation. **The letters must be sent by the recommending diplomates directly to the ECVSMR.**

3. Submission

An electronic copy of this credentials submission form and all supporting documents (in pdf format) plus a non-refundable fee of €350 must be received by the college Secretary at time of submission. The exam fee is 650.- €. All application materials will become the property of the European College of Veterinary Sports Medicine and Rehabilitation.

4. Deadlines

- Applications for the initial applicant pathway will be considered for up to five years after the approval of the College by the EBVS, and it is therefore expected to end 19th September 2022.
- After being accepted to sit the examination, the candidate has a total of four (4) attempts to pass all three parts of the examination within (eight) 8 years.
- Deadline for submission of the credentials to sit the exam 2023: 1. August 2022
- Deadline for application for the exam 2023 and the payment: 1. November 2022
